## **Save Danford Fundraising Campaign Designation of Funds - \$50,000**

The municipal council in Danford Lake, Quebec (Municipality of Alleyn-and-Cawood) is proposing to sacrifice its unspoiled and peaceful environment to build a huge megadump to accept all types of garbage from the entire Outaouais Region, and possibly beyond. Please make a contribution today to help ensure the Coalition has all the resources it needs to stop this travesty. Your contribution will help fund the following:

### **\$25,000                      Independent Environmental Study**

The Coalition would like to conduct an independent environmental study of its own by a certified engineering team of the proposed landfill site. It will duplicate several of the 22 studies already conducted by the promoter, as required by the Quebec government. The Coalition's study would focus on the suitability of the soil for an engineered landfill; the impact of the landfill on the subsurface soils, groundwater and surface water; the impacts of the leachate and treated leachate on the Picanoc River. An independent groundwater expert would also be contracted to participate in the study.

### **\$10,000                      Lobbyists – Fraser Milner Casgrain**

The Coalition has retained a firm to provide government relations and strategic counsel. While the Coalition believes that it is its own best spokesperson, we realize that we need the help of experts to assist us, especially in dealing with the Province of Quebec, both at the bureaucratic and at the political levels. The Public Policy Group of Fraser Milner Casgrain will help ascertain the policy consideration of the Quebec departments that have an influence on the approval of the Danford megadump; assist in the Coalition's key communications with governments; open lines of communication which may not be normally available to the Coalition; and analyzing and providing political advice at the provincial and federal level on the waste management issue.

### **\$10,000                      Legal Counsel**

The Coalition has been fortunate to retain a legal team composed of Nerio De Candido, a Quebec lawyer who advises on a number of municipalities in the Region; and Yvon Duplessis, a recognized expert and teacher of Municipal Law and foremost expert in Access to Information Law. Working with the Coalition since February 2006, they have been instrumental in providing Municipal and Provincial legal advice; reviewing legislation and bylaws; advising on legal principles of due process and strategies; and representing the Coalition on Access to Information proceedings.

### **\$5,000                      Communication and Signage**

A key strategy in the Coalition's efforts to stop the megadump is winning the battle of public opinion. Our efforts are focusing on media exposure; the web-site; direct mail and e-mail communications; public signage; making key presentations; and, developing briefing packages for politicians, bureaucrats and the media. All services are pro bono. Funds are used to cover the costs of key mailings, photocopying and public signage.
